

Summary

Trends of Indian Telecom Industry for May 2020

- 1) Total subscriber base at 1,164 million; YoY de-growth of 1.6%, MoM de-growth of 0.5%
- 2) Overall tele-density stood at 86.2%; Urban tele-density at 137.8%, rural tele-density at 59.2%
- 3) Wireless subscriber base stood at 1,144 million; YoY decline of 1.5%; MoM decline of 0.5%
- 4) Active wireless subscriber base at 961 million; YoY de-growth of 2.9%; MoM growth of 0.3%
- 5) Reliance Jio leads the the market with active wireless subscriber market share of 32.5%, closely followed by Bharti Airtel at 32.0% and Vodafone Idea at 28.8%
- 6) Urban wireless subscriber base at 620.2 million; YoY decline of 5.5%; MoM decline of 1.5%
- 7) Rural wireless subscriber base at 523.7 million; YoY growth of 3.6%; MoM growth of 0.7%
- 8) Wireline subscriber base at 19.8 million; YoY decline of 7.1%; BSNL/MTNL continue to be the market leader
- 9) Broadband subscriber base at 683.8 million
- 10) For December 2019 quarter, total minutes on network grew 6% YoY, while MoU per subscriber grew by 7% YoY.
- 11) For December 2019 quarter, data subscriber base and per subscriber usage continued to report healthy YoY growth

Revenue trends for Indian Telecom Industry for quarter ending December 2019

- 1) Total AGR at Rs. 40,876 crore; YoY growth of 13%
- 2) RJIL continues to lead the market with a revenue market share of 33.6%, followed by BAL at 30.5% and VIL at 25.7%
